

Race-Day Waiver

By registering for the race you indicate your acceptance, you understand, agree, warrant and covenant as follows:

I understand that participating in this event is potentially hazardous, and that I should not enter and participate unless I am medically able and properly trained. In consideration of the acceptance of this entry, I assume full and complete responsibility for any injury or accident which may occur while I am traveling to or from the event, during the event, or while I am on the premises of the event. I also am aware of and assume all risks associated with participating in this event, including but not limited to falls, contact with other participants, effect of weather, traffic and conditions of the road. I, for myself and my heirs and executors, hereby waive, release and forever discharge the event organizers, sponsors, promoters, The Dealio, Hemming Village, and Zombie Chase Race and each of their agents, representatives, successors and assigns, and all other persons associated with the event, for all of my liabilities, claims, actions, or damages that I may have against them arising out of or in any way connected with my participation in this event.

I understand that this waiver includes any claims, whether caused by negligence, the action or inaction of any of the above parties, or otherwise.

I understand that the entry fee is non-refundable and non-transferable. I hereby grant full permission to any and all of the above parties to use any photographs, videotapes, motion pictures, website images, recordings or any other record of this event.

ZOMBIE CHASE RACE REGISTRATION AGREEMENT AND LIABIL-ITY WAIVER (the "Agreement and Waiver")

1. AUTHORITY TO REGISTER AND/OR TO ACT AS AGENT.

You represent and warrant to ZOMBIE CHASE RACE that you have full legal authority to complete this event registration on behalf of yourself and/or any party you are registering (the "Registered Parties"), including full authority to make use of the credit or debit card to which registration fees will be charged. As used in this Agreement and Waiver, ZOMBIE CHASE RACE refers to ZOMBIE CHASE RACE and any and all subsidiaries, affiliated entities, or entities that control or are controlled by ZOM-BIE CHASE RACE, singly or together and its officers, employees, contractors, subcontractors and agents.

If you are registering a child under the age of 18 or an incapacitated adult you represent and warrant that you are the parent or legal guardian of that party and have the legal authority to enter into this agreement on their behalf and by proceeding with this event registration, you agree that the terms of this Agreement and Waiver shall apply equally to all Registered Parties. 2. WAIVER.

5. APPLICABLE LAW; CONSENT TO JURISDICTION.

The ZOMBIE CHASE RACE sites (excluding linked sites) are controlled by ZOMBIE CHASE RACE from its offices within the State of Idaho, United States of America. By completing this event registration, both you and ZOMBIE CHASE RACE agree that the statutes and laws of the State of Idaho without regard to the conflict of laws principles thereof, will apply to all matters relating to this event registration, this Agreement and Waiver, the Terms of Use or other use of the ZOMBIE CHASE RACE sites. You agree that exclusive jurisdiction for any dispute with ZOMBIE CHASE RACE resides in the courts of the State of Idaho and you further agree and expressly consent to the exercise of personal jurisdiction in the courts of the State of Idaho in connection with any dispute including any claim involving ZOMBIE CHASE RACE or its affiliates, subsidiaries, employees, contractors, officers, directors, telecommunication providers and content providers.

6. SEVERABILITY.

You further expressly agree that this Agreement and Waiver is intended to be as broad and inclusive as is permitted by the law of the State of Idaho and that if any provision of this Agreement and Waiver shall be found to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and Waiver and shall not affect the validity and enforceability of any remaining provisions.

PART I

I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM ASSUMING RISKS, AND AGREEING TO INDEMNIFY, NOT TO SUE AND RELEASE FROM LIABILITY THE ORGANIZER OF THE ZOM-BIE CHASE RACE RELAY AND THEIR RESPECTIVE AGENTS, EM-PLOYEES, VOLUNTEERS, MEMBERS, CLUBS, SPONSORS, PROMOT-ERS AND AFFILIATES (COLLECTIVELY "RELEASEES"), AND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS. THIS RELEASE IS A CONTRACT WITH LEGAL AND BINDING CONSEQUENCES AND IT APPLIES TO ALL ACTIVITIES ENTERED AT THE EVENT, REGARDLESS WHETHER OR NOT LISTED ABOVE. I HAVE READ IT CAREFULLY BEFORE SIGNING, AND I UNDERSTAND WHAT IT MEANS AND WHAT I AM AGREEING TO BY SIGNING.

In consideration of the acceptance of my application for entry in the ZOMBIE CHASE RACE, I hereby freely agree to and make the following contractual representations and agreements. I ACKNOWLEDGE THAT RUNNING IS AN INHERENTLY DANGEROUS SPORT AND FUL-LY REALIZE THE DANGERS OF PARTICIPATING IN THIS EVENT, whether as a runner, zombie, volunteer, or otherwise, and FULLY AS-SUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION IN- CLUDING, by way of example, and not limitation: the dangers of collision with pedestrians, vehicles, other participants, and fixed or moving objects and obstacles; THE RELEASEES' OWN NEGLIGENCE, the negligence of others and weather conditions; and the possibility of serious physical and/ or mental trauma or injury, or death associated with the event. For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, AND PROMISE TO IN-DEMNIFY AND NOT TO SUE the Releasees and all sponsors, organizers and promoting organizations, property owners, law enforcement agencies, public entities, special districts and properties that are in any manner connected with this event, and their respective agents, officials, and employees through or by which the event will be held, (the foregoing are also collectively deemed to be Releasees), FROM ANY AND ALL RIGHTS AND CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASEES' OWN NEGLIGENCE TO THE MAXIMUM EXTENT PERMITTED BY LAW, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the event, or travel to or return from the event. I agree it is my sole responsibility to be familiar with the event course and agenda, the Releasees' rules, and any special regulations for the event and agree to comply with all such rules and regulations. I understand and agree that situations may arise during the event which may be beyond the control of the Releasees, and I must continually ride and otherwise participate so as to neither endanger myself nor others. I accept responsibility for the condition and adequacy of my equipment, any equipment provided for my use, and my conduct in connection with this event. . I have no physical or medical condition which would endanger myself or others if I participate in this event, or would interfere with my ability to safely participate in this event. I agree, for myself and my Successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my Successors assert a claim contrary to what I have agreed to in this contract, the claiming party shall be liable for the expenses (including legal fees) incurred by the Releasees in defending the claims. This contract may not be modified orally, and a waiver or modification of any provision shall not be construed as a waiver or modification of any other provision herein or as a consent to any subsequent waiver or modification. I consent to the release by any third party to Releasees and their insurance carriers of my name and medical information that may relate solely to any injury or death I may suffer arising from the event. Every term and provision of this contract is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable.
